



TERMS & CONDITIONS

Read carefully the following terms and conditions of this license agreement before downloading, installing or using the ReachICE mobile software or any accompanying documentation. The terms and conditions of the ReachICE mobile software license regulate the use of the software, unless you and TeknologyLabs Pty. Ltd. have concluded a specific legal agreement regarding the ReachICE mobile software.

The TeknologyLabs Pty. Ltd. and/or its subsidiaries and/or its affiliates, hereinafter referred to as TeknologyLabs, agrees to license the ReachICE mobile software, hereinafter referred to as the SOFTWARE, to you as a physical person, company or legal entity that will use the SOFTWARE, hereinafter referred to as the USER, only under the condition of acceptance of all the terms contained herein. By downloading, copying, installing or using the SOFTWARE, you acknowledge and agree that you understand this contract in its entirety and accept all its terms unconditionally.

This is a legally binding contract between you, the USER, and TeknologyLabs. If you do not accept or agree to the terms of this agreement, please do not download, install, copy, access or make any other use of the SOFTWARE. a) Granting a user license
